## Notes for the Register of Interests for the Private Columbaria Appeal Board 私營骨灰安置所上訴委員會利益登記冊備註

Note 1: In relation to the collection of personal data in this register of interests:

- all panel members (including the Chairperson and Deputy Chairpersons) shall register in writing their personal interests, direct or indirect, pecuniary or otherwise, when they **first join** the Private Columbaria Appeal Board, and **annually thereafter**, to the secretary to the Appeal Board;
- panel members, upon appointment, will have a right to request access to and correction of the information provided in this Declaration and such requests can be made in writing to the secretary to the Appeal Board (11/F, THE HUB, 23 Yip Kan Street, Hong Kong);
- the information provided in this form will be used by the presiding officer and the secretary to the Appeal Board as appropriate to assess whether a panel member may have any conflict of interests in serving on the Appeal Board; and
- the information provided in this register form may be disclosed to the public in connection with your appointment as a panel member of the Private Columbaria Appeal Board.
